# Rules and Regulations

**1.** The Tournament is organised by the Harpenden LTC sanctioned by the Lawn Tennis Association and will be run in strict accordance with the ITF Rules of Tennis the Rules of Lawn Tennis and the LTA Regulations for the Management of Tournaments. This includes the recommended Code of Conduct.

**2.** Age qualification - Entrants must be under the stated age on 31st December 2008.

- 18 & U events    born 1991 or later
- 16 & U events    born 1993 or later
- 14 & U events    born 1995 or later
- 12 & U events    born 1997 and 1998 only  
(unless have LTA passport)
- 10 & U events    born 1999 only

**3.** The Committee reserves the right to decide all questions of eligibility and to refuse entry without assigning a reason and to alter the Conditions if found necessary.

**4.** Doping Statement: I consent to him/her participating in doping control procedures if selected undertaken by an independent sampling officer (ISO) appointed by UK Sport.

**5.** Media Statement: I consent to him/her being involved in any publicity connected with LTA Supported Tournaments, including media interviews, photographs and TV footage. Please inform the tournament organiser if you do not wish him/her to be involved in publicity.

**6.** LTA Membership Record: I consent to the details provided on this entry form to be used to update the LTA's membership record of the person identified.

**7.** Competitors may enter a maximum of 2 singles and 1 doubles event.

**8.** 4 clay courts, 7 artificial grass courts will be available. Old Albanian's Sports Club will be used for the Round Robin U10 Event on Tuesday 26th and Wednesday 27th May. (artificial grass)

**9.** ITF approved tennis balls will be used.

**10.** Play will commence at 9.00 am each day.

Competitors must sign the attendance sheet immediately on arrival and be available to play when called, otherwise they are liable to be scratched. An "order of play" will be posted every evening on the Harpenden LTC website ([www.harpendenltc.co.uk/hojt](http://www.harpendenltc.co.uk/hojt)) and players must check each day from 8pm onwards.

**11.** With the exception of the preliminary rounds of the 10 & under event where play will be on a round robin basis, each match will be the best of three sets, with a third set match tie-break set. The 10U events will play with green balls and will play best of 3 short sets with a match tie break third set.

**12.** Each item of clothing must be accepted tennis clothing. Any competitor who appears on court

dressed in a manner which is deemed unsuitable by the Referee will be liable to be scratched. Rubber soled white tennis shoes only may be worn. Training shoes are not allowed.

**13.** Any person who enters for a Tournament does so at their own risk and there can be no claim against the Organisers for any injury they may sustain unless the Organisers have been guilty of negligence.

**14.** The Committee will endeavour to find partners for players if requested, in which case the words "Partner Wanted" should be added to the Entry Form. All doubles events must be entered on the form.

**15.** The decision of the Referee on all points relating to the running of the Tournament shall be FINAL.

**16.** No complaint in connection with the Tournament can be entertained by the Committee unless made in writing and lodged with the Secretary of the Tournament within 48 hours of the occurrence of the cause of the same and an application for leave of appeal against any decision of the Committee cannot be entertained by the Council unless made in writing and lodged with the Secretary of the Association within 10 days after the receipt of such decision by the complainant (Vide regs. (36) and (37)).

**17.** Vouchers and trophies will be awarded to all Singles winners and Runners-up.

**18.** A Consolation Event will be organised on a rating format, weather permitting. (3 set matches).

**19.** Light lunches, tea and refreshments will be obtainable every day at Harpenden LTC catering arrangements at Woollams will be posted on the website.

**20.** The draw will be posted on the website at [www.harpendenltc.co.uk/hojt](http://www.harpendenltc.co.uk/hojt) from 8pm on Monday 18th May 2009.

**21.** An entry fee of £12.50 for each Singles event and £6.00 for each person for Doubles events is payable by each competitor, and the entry form, must be received no later than Wednesday 6th May 2009. Send to:
